

Whereas if the trustees desire to co-opt another eminent personality as trustees for betterment of trust, they can co-opt. but the total number of trustees shall not be more than eleven.

Whereas the Settler is desirous of establishing a trust for public charitable objects And whereas the trustees have, at the request of the Settler, agreed to act as the Settler trustee/ first trustees of these presents as testified their being parties to and executing these presents.

AND whereas it is necessary to declare the aims and objects of the public charitable trust, being constituted under these presents.

NOW THIS INDENTURE WITNESSES AS FOLLOWS:

1. **THAT** in order to effectuate his aforesaid desire, the Settler has set apart and handed over to the trustees, a sum of Rs. 1100/- one thousand one hundred only (hereinafter called the "Trust Fund" which expression shall include cash and any other property of investments of any kind whatsoever into which the same or any part thereof might be converted, invested or varied from time to time which may be acquired by the trustees or may come to their hands by virtue of these presents or by operation of law or otherwise howsoever in relation to these presents), and the trustees shall hold and stand possessed of the same upon the trust subject to

6. **THAT THE OBJECTS FOR WHICH THIS TRUST IS ESTABLISHED ARE:**

a) **WORK AGAINST CRIME & CORRUPTION**

1. **THE** members of the organization will be liable to collect any sort of information about crime including child labor/human

trafficking/dowry cases and other heinous crimes and inform and help local police and administration.

2. **THE** organization will also spread awareness among masses against the consumption of tobacco products and alcohol & the harmful effects of such products by organizing Nukkad Nataks and other door to door campaigns.
3. **THE** organization will also make aware the masses against the devil of dowry system and how this system is destroying the lives of daughters of the nation and will also take stringent actions against those who are giving dowry and also the acceptors of dowry.
4. **V.A.C.C.** will also encourage the common man to go to police directly or through the organization, as there are lots of crimes which are not at all reported as the common man hesitates in reporting the cases and going to courts.
5. **THE** legal advisory committee of V.A.C.C. will provide free legal advice and help to needy people.
6. **V.A.C.C.** members/officers will be entitled to take direct action through legal proceedings against any government official or politician, if a written complaint is received from a victim who has been harassed by any official.

7. V.A.C.C. officers/members, as they will be working against organized crime, will be entitled to get proper police protection on government expenses.
8. V.A.C.C., to meet its objectives, has the right to organize public rally/march/protest on print or live media.
9. TO lodge any case on any member/officer of V.A.C.C., police department or any other government department, will have to take a written permission from a member of managing committee of V.A.C.C.
10. THE motto of V.A.C.C. is to help Police, Crime Branch and other government organizations in controlling crime and corruption throughout the country starting from the lowest local unit of villages, blocks, districts, states to the entire country level.
11. TO make Awareness about human rights to the general public of the country.
12. TO make Awareness against Rights to Information Act-2005 throughout the country.
13. TO solve the cases and dispute through the Alternative Dispute Resolutions methods.

14. **TO** spread Awareness and protection against domestic violence against women.
15. **TO** arrange legal aid camps to settle disputes amicably amongst the citizens of India and to set up alternative methods of redressal of grievances, especially, by voluntary consent of the adversary parties.
16. **TO** provide direct assistance to the victims of crime through counseling, medical assistance, legal advice and vocational training with a view to their social, psychological and economic rehabilitation.
17. **TO** put our full effort to make India a Crime and Corruption Free Country.
18. **TO** educate the people for adoption of the good norms of a good citizenship and to inculcate into the people's mind, ideals of national unity
19. **TO** establish offices throughout the country, even on village levels, to stop crime and corruptions.
20. **TO** raise funds through collection, donation or subscription and other means and invest money or incur expenditure in such manner as shall promote the attainment of aims and objectives of TRUST.

- 21.TO** undertake any sort of work or assignment that would be for the general welfare of the people.
- 22.TO** spread legal literacy amongst the citizens of India, especially, the weak, down- trodden and poor, irrespective of race, caste, sex, color or creed.
- 23.TO** Release of poor prisoners from Jails and visiting prisons to educate the prisoners and also help the released prisoners to get settled in the society properly and also to assist them in getting some job or other proper sources of earning.
- 24. V.A.C.C.** will also be entitled to issue character certificate, after proper investigation, to any person applying for government or private jobs.
- 25.All V.A.C.C.** officers, having the name plate of their designation on their vehicles, will be exempted from Toll Tax throughout the country.
- 26.V.A.C.C.** works with Centre and State Government to minimize the crime in country.
- 27.V.A.C.C.** main objective is to stop communal riots and make brotherhood among all the people of India.

- 28.TO** achieve social and economic development and improved quality of life for poor and disadvantaged rural households and communities with emphasis on women and children.
- 29.**Any member of V.A.C.C. will be entitled to use sticker of registered logo of V.A.C.C. on his personal vehicle.
- 30.TO** grant, pay or give scholarship, stipends, prizes, rewards, allowance and other financial assistance or help in cash or kind to students with a view to help them in pursuing their studies in schools, colleges, educational institutions, technical institutions, art schools, institutions teaching commercial and other arts including teaching of cultural arts or other training, research or educational works in India or abroad.
- 31.TO** publish and or publishing books, pamphlets, periodicals and newspapers in India or outside for the spread and advancement of education, mental health and culture.
- 32.TO** promotion of skills, vocational and entrepreneurial training targeted at rural women towards the acquisition of self-employable skills for income generation activities.
- 33.TO** establish and manage university, colleges in the field of Medical, Nursing, Dental, Pharmacy, Law, B.Ed., Management,

Residential School / Non residential school, hostel and Industrial Training Institute.

- 34.TO** establish, manage, and assist charitable hospitals, dispensaries, and ambulance services for the benefit of any person or persons regardless of gender, community, caste, creed, race and nationality.
- 35.TO** develop and takeover health care infrastructure and render medical care of the highest order through implementing new medical system, patent drugs and research and provide a forum for useful research on various diseases.
- 36.TO** provide Beti Bachao, Beti Padhao Yojana Government has introduced a new scheme called Beti Bachao, Beti Padhao, which will help in generating awareness and improving the efficiency of delivery of welfare services meant for women with an initial corpus.
- 37.TO** implement the Beti Bachao Beti Padhao programme, a flagship initiative to address issues that affect women, and also reverse the trend of an adverse and declining child sex ratio.
- 38.TO** lodge any case on any member/officer of V.A.C.C., police department or any other government department, will have to take a written permission from a member of managing committee of V.A.C.C.

39. Any member of V.A.C.C. will be entitled to use sticker of registered logo of V.A.C.C. on his personal vehicle.
40. V.A.C.C. Submit the Half yearly Reports of Crime Rate to both Centre and State Home Ministry.
41. **TO** undertake conference, seminars, workshops, symposium, festivals, exhibition, small research projects in connection with cultural activities and preserve or promote cultural heritage, arts, letters and other creative endeavours.
42. **TO** establish a large number of micro enterprises in the rural and urban areas and organize the rural and urban poor into Self Help Groups (SHGs) through the process of social mobilization, training, capacity building and provision of income generating assets.
43. **TO** conduct Vocational Training programs such as dairy, Fisheries, handloom, agriculture, animal husbandry, handicraft, sericulture, social forestry khadi and village industry to empower women.
44. **TO** undertake identification and treatment of drug addict and create awareness about the ill effects of alcoholism and substance abuse on the individual, the family and the society at large.

- 45.TO** undertake, manage and run post graduate, undergraduate and diploma level courses in the field of Business Administration, Computer Applications, Engineering and Technology, Architecture /Planning, Hotel Management and Catering Technology, Pharmacy, Applied Arts and Crafts.
- 46.TO** arrange marriages of adult female and male candidates irrespective of caste creed or color and encourage inter caste marriages in building healthy society and infuse in couples a sense of pride in nationally accepted value and develop consciousness against social evil.
- 47.TO** undertake promotion and development of small rural technologies, micro enterprises, watershed management, wasteland / other unutilized resources development and disinfecting of water by chlorinating for making safe drinking water available to the people.
- 48.TO** conduct and contract for training and research connected with the integrated development of forest resources of the islands and cultivation as well as processing of agricultural, plantation and horticultural crops, medicinal and aromatic plants.
- 49.TO** participate in all emerging issues as well as & cutting edge research whenever occurs and to do all such other lawful acts deeds

and things as incidental and conducive to the attainment of the objects or any one of them in favor of human beings.

b) SOCIAL:

- a. **TO** establish and run various welfare Centre to promote de-Addiction, Welfare of senior citizens, physically and mentally handicapped person and overall human development.
- b. **TO** promote social welfare activities with special emphasis on women empowerment.
- c. **TO** support good governance and anticorruption initiatives at the country level.
- d. **TO** prevent corruption through research, advocacy, lobbying and awareness campaigns.
- e. **TO** stimulate public awareness about corruption, corruption trends, corruption impact and to enable the civil society to raise their voice against corruption.
- f. **TO** work for the betterment of women, children, senior citizens, and disabled and to fight against social wrongs like discrimination and harassment based on gender etc. with a vision of social justice.

- b. **TO** render, advice, give consultation, promote utilization of research and enhance, develop, exchange research programs and establish co-operation between institutions engaged in research in various fields of modern education.
- c. **TO** promote education, especially girls and other deprived section of the society.
- d. **TO** conduct educational, environmental and sociological studies.
- e. **TO** promote use of Information & Communication Technology (ICT) for socio-economic development of the community.
- f. **TO** push for legal and judicial reforms, civil service reform, and effective public administration.

- g. **TO** improve accountability and transparency in political, administrative and social areas.
- h. **TO** advocate a more efficient public financial management and public service delivery.
- i. **TO** construct a consensus for joining hands in corruption control.
- j. **TO** organize training and refresher programmes for the volunteers and officials of different Non Government Organizations to strengthen the development skills of trainees through IEC (information, education and communication) which they can use in the development sector.
- k. **TO** disseminate information and knowledge, to edit, publish, and print literature and documents and to organize seminars/ conference/ meetings etc.
- l. **TO** manage skill development programs and promote participation of youth (unemployed as well as students) in income generation activities.
- m. **TO** organize lectures, seminars and workshops to help or strengthen the character building process.

- n. **TO** remove illiteracy and to spread Adult Education for the age group: 15-35 years.

d) WOMEN EMPOWERMENT:

- a. **TO** fight against all types of violence being committed against girl, child and women and to make aware society against such evils like dowry, molestations and the like.
- b. **TO** train women for self employment through vocational courses to be conducted free of cost to attach and Gate or made on self help group upgrade them about loaded for them by NABARD and other such organization.
- c. Empowering women through marketing linkages of their produces/ products for ensuring food and livelihood security and self sustained economy.
- d. **TO** educate women about family planning and benefits thereof.
- e. **TO** work for uplifting the status of women in the society and to work against female circumcision and fight against the victimization of girl/ women by anybody in the society on female circumcision on any other related issues.

e) HEALTH:

- a. **TO** promote establish, run, develop and manage hospitals, medical colleges, research institutions, counseling centers, dispensaries etc.
- b. **TO** educate people against taking drugs and alcohol.
- c. **TO** provide help under health and nutrition services for women and children.
- d. **TO** organize blood donation camps, immunization and encourage organ donation.
- e. **TO** provide free medicine in deprived residing in rural areas by arranging medical fair mobile dispensaries giving free medicine.
- f. **TO** create awareness as to fight disease like leprosy, tuberculosis, malaria, jaundice, Cancer, HIV/ AIDS etc.

f) ENVIRONMENT:

- a. **TO** work for environmental awareness, sustainable development and participative management of local natural resources for village level development.
- b. **TO** ensure environmental sustainability, ecological balance, production of flora and fauna, Agro forestry, conservation of natural resources.
- c. **TO** resist deforestation and to encourage Plantation and Forestation.

- d. **TO** create awareness about disaster management and to help the victims of natural disasters like floods, earthquake, Tsunami, fire, wind storm, cyclone etc.

- b. **TO** promote organic production and their marketing in the area of agriculture.

h) **ANIMAL WELFARE** :

- a. **TO** work for animal husbandry, animal medical care, animal right and to implement project on Development on fisheries.
- b. **TO** help the victims of natural disasters be it animals.

i) **SPORTS** :

- a. **TO** organize Sports events and talent search events for the youth.

- b. **TO** promote and provide training for rural sports, National recognized sports and Paralympics sports and Olympic Sports.
- c. Career games as to the development of an education courses.

j) OTHER :

- a. **TO** public newspaper, magazine, general and reproduce of arts, literature, science, craft and other allied works/ collections of works of arts for instruction and imparting useful knowledge.
- b. **TO** eliminate Poverty, unemployment and starvation such as rural industries, home industries, small industry, small scale industries and efforts to ensure proper market conditions.

7. PATRONS:

THE governing body may according to such terms and condition as it shall decide from time to time admit as patrons those persons who are likely to help in furthering the objective and causes of the trust either through their professional knowledge and experience and /or through financial assistance.

8. TRUSTEES:

8.1 All persons who have attained 18 years of age and have subscribed to the aims and objects of the Trust subject to the approval of the Governing Body will be entitled to be its Trustees. The Decision of the Governing body in this regard shall be final and binding.

8.2 The Trustees will not be entitled to receive any profit, but the Trustees may receive honorarium and reimburse all expenses actually incurred by them in connection with their duties relating to Trust.

8.3 The Trustees shall be accountable only for such moneys, and funds, which will actually come into their hands.

9. TERMINATION OF MEMBERSHIP OF TRUSTEE:

9.1 On Death

9.2 On written resignation

9.3 On becoming of unsound mind

9.4 If found to be involved in any anti-social activities

9.5 If found guilty by means of anti-propaganda of the Aims and Objects of the Trust.

9.6 If has not attended three consecutive meeting of the Governing Body without information.

9.7 If he is requested to resign by 2/3rd or as near thereto possible of the remaining Trustees.

12.1 **THE** governing body will be held, at least, once in four months, notice of such meeting being given, at least, 15 days in advance.

Decision will be taken as far as possible by consensus and in the event of any difference by majority where the votes are equal, the Chairman will have the casting vote.

- 12.2 **THE** meeting of the Governing body shall be held at such time and place as the Chairman may decide from time to time and all the meeting of the Governing Body shall be presided over by the Chairman and in his absence by any one of the trustees. The annual general meeting shall be held not latter than six months after the closing of the financial year.

13.ACCOUNTS**13.1 AUDIT OF ACCOUNTS:**

A Chartered Accountant shall audit the accounts of the trust/society every year.

13.2 OPERATION OF BANK ACCOUNT:

THE governing Body have power to open account in the name of the Trust, with a Bank or Banks, to operate any government or private bank such account and to give instructions to the Bank and to provide for opening and operation of such account by one or more of the Trustees or by an agent appointed by the Trustees.

13.3 SETTLEMENT OF ACCOUNT:

THE Governing Body will settle all accounts and to compromise, abandon, or refer to arbitration any action or proceedings or disputes, claim, demand or things, as deemed proper for such purpose without being responsible for any loss occasioned thereby.

14. BRANCH OPERATION :

Branch can be open in any state of India; no new registration would be required for state branch office.

15. POWERS AND FUNCTION OF OFFICE BEARER:**PRESIDENT:**

- I. President shall preside over all the meeting of the trust and have the power to allow inclusion of any subject/matter in agenda for the discussion in the course of proceeding/meeting.
- II. President shall make disbursement in accordance with the direction of Governing Body and shall maintain accounts books minute register and manage daily routine correspondence.
- III. At the time of voting on any matter/subject if the total votes of the group of members happen to be equal in number; the

President will have casting vote to decide the matter/subject.

- IV. President shall preside over all the meeting of the society.
- V. At the time of voting on any matter/subject (except election) if the total votes of the group of members happen to be equal in number; the Chairman has the power to cast an extra vote to decide the matter/subject.
- VI. President shall have the power to allow inclusion of any subject/matter in agenda for the discussion in the course of proceeding/meeting.
- VII. President shall be convener of all the meetings and without his/her signature on the notice of meetings no meeting will be valid. It shall be his/her duty to see that the resolution at the respective meeting is implemented and given effect timely.
- VIII. President shall be at liberty to spend for the purpose of the Society without sanction of the Managing Committee and to do all such other lawful things as incidental or conducive and expedient to the Society.
- IX. While purchasing or acquiring any movable or immovable property on behalf of NGO the President will sign along with secretary.
- X. In case of resignation of the President it will be addressed to Secretary

SECRETARY:

The Secretary shall enjoy all the powers of President in his/her Absence.

- I. Secretary will prepare the Membership Register as well as the Proceeding Register to record the minutes of the proceedings of the Governing Body Meetings and have them duly signed by the members who attend the meetings.
- II. Secretary shall maintain the accounts of all money, which is received and/or paid by him/her on behalf of the trust.
- III. Secretary shall make disbursement in accordance with the direction of Governing Body.

FINANCE EXECUTIVE (TREASURER):

- I. Treasurer shall maintain the accounts books and all money, which is received and/or paid by him/her on behalf of the trust.
- II. Treasurer shall make disbursement in accordance with the direction of Governing Body.

16.FINANCIAL YEAR:

The financial year of the trust shall be from 1st April to 31st March of every year.

The trust may sue or be sued in the name of the **Managing Trustee**

18. RECORD

The Governing Body will maintain a record of investments and disbursements besides a Minutes Book recording all resolutions and proceedings for every meeting duly confirmed at next meeting and attested by the Chairman of the next meeting.

19. COMMITTEES:

Trust can permit its beneficiaries to elect committee or committees from among themselves for the smooth and efficient running of any particular branch of its activities. They can form rules and regulations for that particular branch under the given condition.

20. TRUST FUND:

- 20.1 **THAT** the trust fund may be augmented by the income from donations, contribution from members and Government aids etc.
- 20.2 **THAT** the trust fund shall not be applied for any purpose other than those specified in Para 5 herein above unless the other objects added to the trust objectives.
- 20.3 **THAT** the Trustees shall always maintain proper books of accounts which shall be kept at the office of the trust.

20.4 In the matter of investment of Trust funds, the provision of section 20 of the Indian Trust Act 1882 shall apply.

21. POWER AND FUNCTION OF THE GOVERNING BODY:

21.1 To fill the vacancy created by death or otherwise within three month of the occurrence of such vacancies by appointing any person as trustee.

21.2 The Governing Body of the trust will be empowered to open administrative office, Regional office, branch offices and central office of the trust in different states of India.

21.3 To administer and control the affairs and funds of the Trust and exercise all power of the Trust in order to carry out the aims and objects of the Trust and manage all the institutions established by the Trust.

21.4 To purchase take on lease or in exchange or hire or otherwise acquire any movable or immovable property for the purpose of the Trust and to carry out agreement, loan, grants and other assistance in suitable terms.

21.5 To provide grant in-aid and other financial assistance to voluntary organization and work as link between NGO's

working in different parts of India and donor agencies and individual donors.

- 21.6** To accept any donation, contribution, grant-in-aid, subscription in cash or in kind from any person, body of persons, trust, foundations, institutions, Govt. Departments or Funding agencies with or without conditions.
- 21.7** To apply the whole or any part of the income of the trust, or the trust fund or accumulations thereto to, any one or more of the objects of the trust, as the trustees may, in their discretion, deem fit from time to time.
- 21.8** To start, abolish, discontinue and restart any charity of charitable institutions for the benefit of general public and to impose any conditions to any subscription or donation made by them.
- 21.9** To take over, acquire, manage, control or amalgamate with any Institution having objects either wholly or in part similar to the objects of this Trust and on such terms and conditions as may be thought expedient.
- 21.10** To join, co-operate or amalgamate this trust with other or others having allied objects upon such terms and conditions as the trustees may in their discretion think fit, particularly having

regard to and in conformity with the objects and nature of this Trust.

21.11 To make, vary, alter or modify schemes, rules and regulations for carrying out the objects of the Trust and for the management of the affairs thereof and /or running any institution in furtherance of the objects of the Trust and otherwise for giving effect to the objects of the Trust.

21.12 To give aid by way of donations out of the income or the corpus of the Trust Fund or otherwise to different charitable institutions, societies organizations or Trusts in India which may have been established or which may hereinafter be established for the like charitable purposes

21.13 To grant loan to institutions or persons either on interest or without interest on such terms and conditions as trustees may in their absolute discretion think fit and set apart and/or allocate the whole or a part of the income or the corpus of the Trust Fund.

21.14 To apply for grant-in-aid or donation to the Government Departments and Funding Agencies and to accept grants, donations, gifts, subscriptions, affiliation and other assistance with a view to promote the objects of the Trust and to put to any proper condition upon which such grants and other payments may be made.

21.15 The Governing body shall meet as often as necessary but at least once in every calendar quarter at such place and time as the Managing Trustee may decide. He will send the notice and agenda of these meetings to all members of the Governing Body at least fifteen days before the date fixed for the meeting. The quorum for the meeting shall be one third subject to minimum two trustees.

21.16 Whenever the Managing Trustee is of the opinion that a special meeting of the Governing Body is to be called to discuss and decide an urgent matter of shorter duration the Managing Trustee and any one of the trustees will form sufficient quorum and they may take necessary decisions on behalf of the governing Body in such emergency meeting.

21.17 The Governing Body shall have the power to determine in case of doubt whether any money or property shall for the purpose of the charity be considered as capital or income and whether out of income or capital any expenses to be paid provided that nothing contained shall be deemed to Trustees to spend the income or corpus of the trust for any purpose not authorized by these presents.

21.18 To engage or make provision for the engagement of any person (including all or any of the Trustees and committees or

administrator or Managing Trustees or otherwise) for the purpose of the administration of the Trust in such rules and regulation as the Trustees may prescribe and also to engage or provide for the engagement.

21.19 To borrow moneys either on the security of any property comprised in the Trust Fund or otherwise for all or any of the purpose of these presents, and it shall be lawful for the trustee to make such borrowings on payment of such interest and otherwise on such terms and conditions as they may in their absolute discretion think fit.

22. INVESTMENT:

We undertake that the society/trust/company would only invest its money in the forms or modes specified in section 11(5) of I.T. Act. We further undertake that the company/society/trust/ will insert relevant clause in desired format in MOA/Trust Deed, if required.

23. AMENDMENT:

We undertake that the company/society/trust will not make any amendment in the object clause without the consent of concerned authority. We further undertake that the company/trust/society will insert the relevant clause in MOA/Trust Deed, if required.

24. IRREVOCABILITY:

VOICE AGAINST CRIME AND CORRUPTION

We undertake that the trust/ company is irrevocable in nature and in case of winding up or dissolution of the trust, property of the trust/society/company shall be given or transferred to such other company/society/trust having objects similar to the objects of the trust/society/company. We further undertake that the trust/company will insert the relevant clause in desired format in MOA/Trust Deed, if required.

25. BENEFICIARY:

We further undertake that the trustees or their relatives would not be beneficiary of the trust. The beneficiaries of the trust would be weaker section of the society/trust/company and the people generally required help and assistance in different facets of their lives.

26. SEAL OF THE TRUST

Whenever the seal of the Trust is to be affixed to any writing deed or document executed by the Trust the same shall be affixed in the presence of persons executing the document. The seal of the Trust shall not be affixed except under the authority of a resolution of the Governing Body.

27. DISSOLUTION:



In the event of dissolution of the trust the funds / assets will be transferred only to some other trust / society having similar objectives after adjustment of liabilities.

In the Event of Dissolution of the Trust, the entire Society funds shall be realized and first be used for payment of liabilities of the trust. The assets left if any, shall be disbursed, after obtaining prior approval of the commissioner of Income-tax (Exemption) New Delhi, to other Trust having similar objectives and who have been granted registration u/s 12AA of the Income Tax Act, 1961. In no circumstances it shall be distributed in any manner, to any member of the Trust or their relatives or related concerns.




